3:30

2/18/98 Met with EL asked him
what I could of done more to compromise with
his wants. I told him I had six pieces
of documentation saying I had On App't.
His comment was that he didn't have 6
I said you had my weekly work sched. & the
others were posted in Supvs & Back Room
plus my Ass't & other Supv. knew. He stated
BUT we didn't know I said IF you would
of been here @ work on Fri I would have
told you. He then said TRS didn't know
I told him I am positive I stated as we
were leaving on Fri when TRS said see you

about 20 minutes ago I heard
a noise of men running down the hill
and I looked outside & saw 20 men &
no more up hill when I went outside &
hearing some voices I went outside
(I had no idea who it was) (etc) but we had
no one there & I took notice when
when the soldiers had all gone &
there about 20 men total whom were piled
up against the hillside starting up in
some houses which were all broken up
as well as that they kept on falling down
other pieces of stone were flying around me
