 My asst. just didn't pick them up & turn into
 office He then said quit trying to blame
 others for your is your responsibility. I then
 said this is not a blame to others. He said that
 He had no problems with E.G. paper its always
 in office or on his Desk. & Q.H. paper is in
 sealed envelope. I then asked him was he
 saying that E.G. asst. has never taken Eds Blue
 sheet into office. or who has delivered Dale's
 Time off sheets from Lodi his asst BO. or some
 one else coming from Lodi to the Dist office
 He had no answer. I then asked him when
 did it become a procedure to put Blue Time off sheet
 on his desk, I thought the only paper to put on
 his Desk was the weekly schedule. The Schedule
 was his answer. I then said it was, so whats
 the Big Deal. Mine was on my Desk. That this was
 just petty. I then told him if I hadn't filled out
 Time off sheet then he would have a right to be

That night after work I removed all of my private files concerning events & persons conduct from my office. Over the weekend went through my notes. I could not find my notes of that event, I also discovered other situations described in notes were missing also
