

He went back to work Monday but he wears rubber boots, jumps fences, is in mud, etc. He felt good by Thursday, bothered a little on Friday and then he poured some concrete at home on Saturday and it hurt on Sunday. He has a little bit of swelling, a little stiffness. He has a good range of motion, no crepitus, negative McMurray.

I gave him a few Orudis out of the office. He will taken these for a week or ten days and I will see him again in about three weeks. His progress is satisfactory.





The patient was seen in the office on 06-30-89. It has been about ten days since we arthroscoped his knee for a tear in the posterior horn of the medial meniscus. He seems to be doing quite well. He uses a cane. He has a little swelling. He was given some Naprosyn to see if we couldn't diminish the swelling. He is to increase activity using his knee as a hinge.
