


We are exposed to myriad chemicals daily — including many from natural sources, including the food we eat. Virtually all chemicals can be "toxic" at certain doses and under certain conditions of exposure, but it is the dose that makes the poison. The mere ability to detect the presence of a chemical does not mean that it presents a human health hazard. And, contrary to what Ms. Imus asserts,



many chemicals have been tested — in animal and microbiological models — but few pose dangers to humans at the low levels commonly encountered. —Dr. Allems

As regards the history of psychiatry: it is a history of increasing understanding of mental disorders, better treatments, improved care of those with psychiatric conditions, and a constant battle against the stigma of mental illness that still leads to psychiatric patients being less well treated than those with physical illness. Psychiatry aims to combine the science with caring, understanding, and support for those who suffer from mental illness, human qualities that I hope we can all share —



In support of their motions for summary judgment, defendants submitted declarations from two physicians, Dr. Michael Fischman and Dr. Thomas Allems, both of whom are experts in occupational and environmental medicine and toxicology. They each performed "Independent Medical Examinations" on and reviewed the medical records of all plaintiffs who made themselves or their records available. They also reviewed relevant environmental and environmental health reports related to the grading of Parcel A. Both doctors concluded: (1) the plaintiffs' various ailments were neither caused nor exacerbated by exposure to asbestos, and (2) none of the plaintiffs suffer from asbestosis, asbestos-related lung disease, mesothelioma, or any other illness related to asbestos exposure.

In support of its summary judgment motion, CH2M Hill also submitted the declaration of Dr. David Weill, an associate professor in pulmonary and critical care medicine at Stanford University Hospital, who had reviewed the plaintiffs' medical records. Dr. Weill concluded that none of the plaintiffs suffered from any asbestosrelated disease, process, or condition.

In addition, defendants submitted various independent studies and reports that addressed the possible health risks from the release of airborne asbestos from Parcel A. For example, in February 2007, Arc Ecology, a nonprofit public interest organization that provides environmental technical advice and support to environmental justice communities and local governments on the cleanup and reuse of closed military facilities, issued a report following an investigation of allegations regarding possible health threats from asbestos dust at the Parcel A site. The report concluded that, while Lennar had experienced ongoing difficulties complying with the asbestos and dust control plan,



No More Tears shampoo, no more fears? Not so fast

Phenoxyethanol: From the EWG website—"Other HIGH concerns: Irritation (skin, eyes, or lungs), Occupational hazards; Other MODERATE concerns: Organ system toxicity (non-reproductive)"

Citric acid— Watch out!. You could get hit by a truck delivering it.

If this sounds ridiculous to you, it is. And so are the claims about the original formula. But J&J was "forced" to make these changes because of falsely perpetuated claims, not science. But it has accomplished nothing, and has cost them millions of dollars – and who do you think will wind up paying this increased cost?

Dr. Bloom concludes, "There isn't a single chemical around that won't be toxic at some dose. But by cynically taking advantage of the public's ignorance of science and a general fear of all chemicals, these groups get funding, publicity, and recognition. In this case they made Johnson and Johnson fold up like a three dollar lawn chair. Others will inevitably follow."


