Part of Body: Right Knee

Subjective complaints: Tiffany returned to work January 5, but she is having a fair amount of pain in her knee. The pain is diffuse along the anterior joint line.

Objective findings: On physical examination, she has no effusion in her knee. Good range of motion. She is somewhat tender along both the anteromedial portals and patellofemoral joint. Her pain is not localized to the lateral joint line.

Assessment: Pain about the right knee following partial lateral meniscectomy.

Plan: The patient was reassured. She does not have significant inflammation of the knee, and therefore I feel that she can continue working. She does take six 7.5 mg hydrocodone per day, and I have asked her to try to decrease this amount of narcotic. I will see her as scheduled on January 22.
