Dear Sir or Madam:

This letter is in reference to the temporary disability payments that I received from July 21, 2008 to August 13, 2010. It appears after careful review that I was not paid the correct amount. I was supposed to be paid at 2/3 of my regular pay. Please see attached spreadsheet for details showing that this is not what I was paid.

I do not owe you for overpayment of benefits. I believe that instead you owe me additional funds. When I consider what I have lost--income, social security being paid in for me, retirement benefits, seniority status, vacation time accrued, lost holiday pay, sick leave and more--because the injuries that brought about my temporary disability, I find it frustrating that I should have to write this letter. I have had to endure pain and suffering in addition to the other listed details. I am behind a total of 40 pay periods where I suffered (and will suffer in the future for) longevity increases and vacation increases.

Furthermore I totally disagree with your decision to change my pay status from temporary to permanent disability based on Dr. Tabaddor's one evaluation of me. This declaration of permanent and stationary disability contradicts both my physical therapist Daniel Sartori and my surgeon Dr. Gary Murata whose care I was under at the time and have seen on a regular basis. These two specialists were both in agreement that I was not permanently disabled and stationary at the time I was seen by Dr. Tabaddor. Although it is to the benefit of the insurance company to be in agreement with Dr. Tabaddor, it contradicts the two primary physicians whose care I was under during the whole time I was affected by all three injuries.

Because we disagree with this issue, it is in my opinion that we need to go before a work comp appeals board for another opinion.
