OBJECTIVE:

She appears well, vital signs are as noted. Ears normal. Throat and pharynx normal. Neck supple. No adenopathy in the neck. Nose is congested. Sinuses non tender. The chest is clear, without wheezes or rales.

ASSESSMENT:

viral upper respiratory illness

PLAN:

Symptomatic therapy suggested: push fluids, rest and return office visit prn if symptoms persist or worsen.

Lack of antibiotic effectiveness discussed with her. Call or return to clinic prn if these symptoms worsen or fail to improve as anticipated.

Talked to patient about long term problems with her sinuses and chronic fatigue due to lack of rest.

Advised to rest and drink enough fluids.
