**DRESS CODE:** Proper dress attire is required. No shorts or tank tops are allowed. No bare midriffs. No T-Shirts with inappropriate messages can be worn in the courtrooms.

**POSTPONEMENT:** You may request a one-time postponement by completing and returning the RESPONSE FORM on the back of this page. **Students are not exempt from jury service. Please request a postponement to your next school break.**

**COURTHOUSE SECURITY:** All persons entering the courthouse will be required to pass through weapons screening (similar to the Airport screening requirements). Visit [www.stocktoncourt.org](http://www.stocktoncourt.org) for a list of prohibited items.

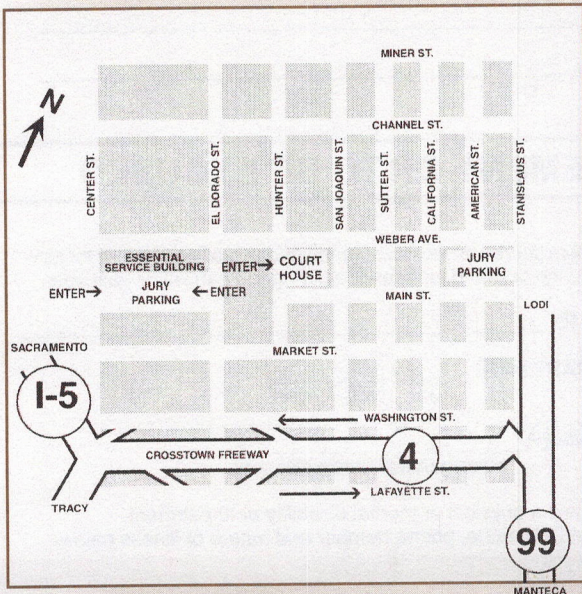
COUNTY OF SAN JOAQUIN, 222 E. WEBER AVENUE, STOCKTON, CA 95202

**DIRECTIONS:** From Interstate-5, take the Downtown Stockton off-ramp towards Center St. (one way to the right). Cross Center St. to El Dorado St. (one way to the left). Turn left onto El Dorado St. Go 3 blocks, then turn right onto Weber Ave. The Courthouse is the large green building on your right.

**From Highway 99,** take Highway 4 west. Take El Dorado St. exit (one way to the right). Go 3 blocks, then turn right onto Weber Ave.

**PARKING:** As a juror you may park free in the Essential Services Building (see map), if you bring your parking ticket to the Jury Assembly Room for validation. The parking structure is one block west of the courthouse, just off Weber Ave., at 15 N. El Dorado St. Enter on Center St. or El Dorado St. Lost tickets may be subjected to a charge of up to \$40.00. The Superior Court and the City of Stockton are not responsible for loss by fire, theft, vandalism or other causes. Designated HANDICAPPED PARKING is available on Weber Ave., San Joaquin St. and Main St. as well as at the Essential Services Building. If the parking lot at 15 North El Dorado St. is full, or if you have an oversized vehicle, you must park at Lot K or L, which is located on American St. between Weber Ave. and Main Street.
