My name is Tiffany Kay Anderson. I live at 2 N Avena Avenue Lodi CA 95240. I can be reached at 209-625-8587 that is a landline.

I was employed as a Pesticide Applicator for San Joaquin County Mosquito & Control District from 2004 until I was forced out of my job with bodily injury and two injuries concurrently.

My employer has two locations where employees are required to work the course of the day. Unbeknownst to myself I was assigned to work in a fish hatchery where Formalin and Copper Sulfate among other medicines and chemicals were used in water that is not potable. These ponds are not lines and they do leach into the water table and run into the waters of the US.

Within my first year of employment I was not certified or trained in injury protocols and I filed 3 DWC 1 forms mandated by my supervisor for exposures. My supervisor who is now deceased from exposure to formalin gave me 20 years of documentations of employees being abused for being injured or sick.

I filed a work comp claim in 2011 7 years into my employment when my medical symptoms justified proof of ever exposure to Formalin. The Grand Jury discovered the violation of prop 65 and title 8 violating Federal law as well as California law and this is how I found out. My employer reprimanded me for being excessively ill. Never informing me they were the cause.

I have repeatedly requested my medical records by my employer and their law firm and they have been tampered and the majority of the records are gone. According to federal law my employer is required to maintain my medical records entirely 30 years after my termination.

I have been forced out of my job for getting injured and I have a lab result that states I have abnormal high readings for leukemia. I owe a credit bureau for medical bills I can't pay when my claim was valid and never should have been denied. I have been too sick to fight for my rights.

I am asking the department of Labor to successfully retrieve my whole medical file with 8 work comp claims that need medical attention.

I am also in request for purchase orders for all chemicals, medicines and treatments used by the San Joaquin County Mosquito & Vector Control District for the years 2003-2011.

I ask that all hard copies of treatment records at the White Slough Facility be kept in tact as evidence. I have carbon copies not originals and they do not align with records an employee was able to give as evidence to the Grand Jury.

I am willing to pay all fees for purchase orders.
