ASSIGNMENT

Our office received this case assignment on January 25, 2010. We were requested to conduct 2 days of surveillance in order to determine the Claimant's current level of activity.

INVESTIGATION SUMMARY

Wednesday January 27, 2010, between the hours of 6:43 am and 11:30 am, on this date the Claimant departed her residence early in the morning wearing a black sweatshirt, black running pants and white tennis shoes. She stopped at a Starbucks drive thru and a Chevron gas station located on West Lane. The Claimant was sitting inside the vehicle while talking on a cell phone. She then exited and fueled her vehicle. She was mostly out of view due to obstruction. She then departed the area. The Claimant took West Lane Rd and headed into Stockton. Contact was broken near Edison Street and Magnolia. A detailed search of the area was conducted, however the Claimant was not relocated. Approximately **28 seconds** of video was obtained of the Claimant talking on a cell phone and exiting her vehicle.

Wednesday, February 3, 2010, between the hours of 7:20 am and 11:00 am, on this date the Claimant's vehicle was not present upon arrival. Her whereabouts was unknown as surveillance was discontinued.

Tuesday, February 9, 2010, on this date the Claimant's vehicle was again not present at the residence. Due to the unknown whereabouts of the Claimant, surveillance was discontinued.

Wednesday, February 10, 2010, on this date the Claimant's vehicle was again away from the residence as surveillance was discontinued.

Thursday, February 11, 2010, on this date the Claimant's vehicle was found to be present in the afternoon. There was no activity noted and she remained out of view as surveillance was discontinued.

Thursday, February 18, 2010, between the hours of 5:25 am and 9:30 am, on this date surveillance was initiated in the early morning. The Claimant's vehicle was not present upon arrival. A Ford Focus, CA license plate 8898H DP was present. This vehicle was found to be registered to a Mary Jean Parvin. Due to the Claimant's unknown whereabouts, surveillance was discontinued.

Saturday, February 27, 2010, on this date the Claimant's vehicle was not present at the residence. Her whereabouts remained unknown as surveillance was discontinued.

Thursday, March 4, 2010 between the hours of 1:00 pm and 9:00 pm found the Claimant to emerge from her residence in the afternoon, and retrieve objects from her vehicle. She again emerged and pulled the garbage can to the street, and later placed garbage in the can. She remained at the residence as surveillance was discontinued. Approximately **3 minutes and 40 seconds** of video was obtained of the Claimant standing and walking about, carrying an armload of objects in both arms, carrying other small items, leaning and reaching into her vehicle, pulling the garbage can. She did not display any apparent restriction or discomfort, and did not use any visible medical apparatus or device while conducting these activities.

SURVEILLANCE LOG

Wednesday January 27, 2010

- 6:43 am The Investigator arrived at the vicinity of the Claimant's purported residence at 2 North Avena Avenue in Lodi CA 95242. The residence can be described as a single story, single family house located on the corner of North Avena Avenue and Oak Avenue. The exterior of the residence was white with bricks. There were no cars parked in the front of the residence. At this time there was no lights on inside or outside the residence. A black Ford Mustang, CA License plate 6HWR601, was parked on the side street next to the residence. There was no activity at this time.
- 9:05 am The Claimant exited the residence out of a rear door. The Claimant can be described as a Caucasian female, approximately 5'8"-5'9" tall, 120-125 lbs. She was wearing a black sweatshirt, black running pants and white tennis shoes. She had a white towel in her left hand. The Claimant remained in her vehicle for a few minutes before departing. Due to obstruction, no video was obtained.
- 9:15 am The Claimant arrived at a Starbucks Coffee Shop and waited in the drive thru line for several minutes, mostly out of view.
- 9:25 am The Claimant departed the area.
- 9:27 am The Claimant arrived at the Chevron gas station next to the Starbucks. She was seen sitting inside her vehicle and talking on her cell phone. She then exited the vehicle and moved out of view.

- 9:28 am Due to heavy traffic at the gas station there was no location from which to obtain video of the Claimant as she fueled her vehicle.
- 9:31 am The Claimant departed the gas station and headed toward Stockton.
- 10:08 am Contact was broken on Edison Street and Magnolia Street in Stockton CA. A detailed search of the area was conducted including nearby gyms, yoga studios and retail areas, however the Claimant was not relocated.
- 11:30 am Investigator returned to the Claimant's residence. Her vehicle was not present upon arrival. Surveillance was discontinued.

Wednesday, February 3, 2010

- 7:20 am Surveillance was begun in the vicinity of the Claimant's reported residence located at 2 N. Avena Avenue in Lodi. Upon arrival, the residence was dark inside, with closed blinds, no lights on and no activity. No vehicles were parked on the street in front to the residence or in the driveway. A secure surveillance position was established with the front of the residence and vehicles in view
- 10:30 am A check was conducted at a prior address found during database searches located at 1516 Sylvan Way, Apt. 205, Lodi, CA 95242 at the Sylvan Way apartment complex, however the Claimant's vehicle was not present.
- 10:42 am Investigator returned to the residence on N. Avena Avenue. There were no changes noted upon arrival.
- 11:30 am There was no activity at the residence, and there was no answer to the front door. Surveillance was discontinued.

Tuesday, February 9, 2010

- 6:00 am Surveillance was begun in the vicinity of the Claimant's reported residence located at 2 N. Avena Avenue in Lodi. Upon arrival, the residence was dark inside, with closed blinds, no lights on and no activity. No vehicles associated with the Claimant were present.

6:30 am Due to the unknown whereabouts of the Claimant, surveillance was discontinued.

Wednesday, February 10, 2010

6:20 am Surveillance was begun in the vicinity of the Claimant's reported residence located at 2 N. Avena Avenue in Lodi. Upon arrival, the residence was dark inside, with closed blinds, no lights on and no activity.

7:00 am Due to the unknown whereabouts of the Claimant, surveillance was discontinued.

Thursday, February 11, 2010

2:19 pm Surveillance was begun in the vicinity of the Claimant's reported residence located at 2 N. Avena Avenue in Lodi. Upon arrival, the residence was dark inside, with closed blinds, no lights on and no activity. The Claimant's black Ford Mustang was parked on the street in front of the residence.

3:00 pm There was no activity at the residence. Surveillance was discontinued.

February 18, 2010

5:25 am Surveillance was begun in the vicinity of the Claimant's reported residence located at 2 N. Avena Avenue in Lodi. Upon arrival, the residence was dark inside, with closed blinds, no lights on and no activity. The Claimant's black Mustang was not present, and on the street was a green Ford Focus, California license plate # 8898HDP. This vehicle was found to be registered to a Mary Jean Parvin.

7:05 am A check was conducted at the Sylvan Way apartment complex, and the Claimant's vehicle was not present. Surveillance was resumed at the N. Avena residence.

9:30 am There was no activity noted and no changes at the residence. Surveillance was discontinued.

February 27, 2010

1:00 pm A spot check was conducted at the Claimant's reported residence in Lodi. Upon arrival, the residence was dark inside, with closed blinds, no lights on and no activity. The Claimant's vehicle was not present and the spot check was soon discontinued.

Thursday, March 4, 2010

1:00 pm Surveillance was begun in the vicinity of the Claimant's reported residence located at 2 N. Avena Avenue in Lodi. Upon arrival, the residence was dark inside, with closed blinds, no lights on and no activity. The Claimant's black Ford Mustang was parked behind the green Ford Focus. A secure surveillance position with the front of the residence and vehicles in view was established.

5:32 pm The Claimant emerged from the residence, and approached her vehicle. She reached about in the trunk, and soon carried an armload of unidentified items to the residence, and out of view. She was attired in dark sweat pants, and a dark sleeveless tee-shirt.

5:35 pm The Claimant again emerged from the residence, and approached the passenger door. She reached about inside, and carried more items to the residence, and out of view.

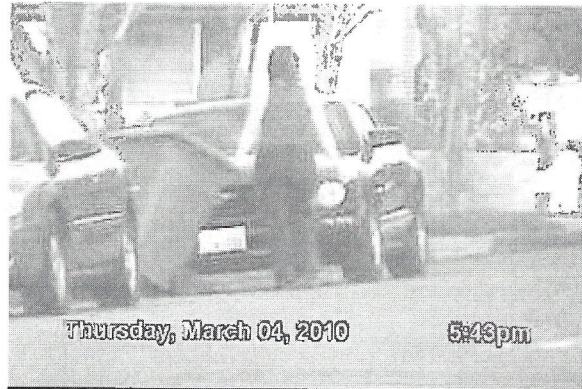

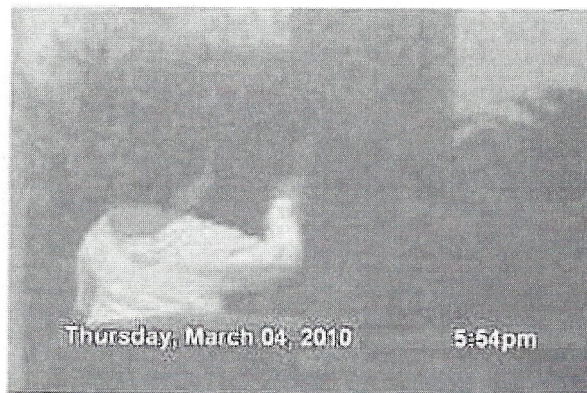
5:43 pm The Claimant emerged from the residence, and approached the garbage can in the driveway. She pulled the can to the street, and soon returned to the residence.
