A contesting person may appeal any final decision of the administrative hearing officer within 20 days after the mailing of the final decision (California Vehicle Code §40251, §40255, and §40256).

Failure to respond to this notice either by sending payment or the completed Affidavit of Non-liability/Administrative Review Request will result in an increase in fees being added and also may result in referral of the amount due to a collection agency and/or withholding of your vehicle registration by the Department of Motor vehicle (California Vehicle Code §4770 and §40267) until payment is made in full.
