Following review and discussion of the Consent Calendar, it was moved by Trustee Groen, seconded by Trustee Page, to approve the Consent Calendar as presented; the motion was unanimously approved.

4. Status on sale of surplus District property, 200 N. Beckman Rd, Lodi.

Report on progress as it pertains to sale of property

Jim Martin of Lee & Associates, informed the Board the buyer's lender is requiring that a Phase II report be conducted to evaluate the potential presence of petroleum hydrocarbons that may have leaked from the hydraulic lift located in the shop. The buyer will be responsible for costs associated with the Phase II investigative report. Mr. Martin stated the buyer had received permits to drill holes required for testing. The drilling is scheduled for Friday June 19th. Mr. Martin also received the "Read and Rely" letter signed by Neil Anderson and Associates required by the buyer's lender. Mr. Martin stated hopefully everything will be completed by the next board meeting and recommended the close of escrow be extended to July 31, 2015, due to the most recent information regarding the Phase II investigation process. The Board demonstrated interest in this being the last extension. Following review and discussion of the Beckman Rd. property, it was moved by Trustee Meeker, seconded by Trustee Colombini, to extend the escrow deadline as presented; the motion was unanimously approved.

5. Report of Budget Committee meeting.

Manager Lucchesi reported that the Boards' Budget Committee of Groen, Khweiss, Fiori, and Lambdin (representing absent committee member Miller) met prior to the Board of Trustees meeting to review the first draft of the 2015-16 expenditure and income budgets. Emily Nicholas passed out the draft budget to the full Board. Manager Lucchesi reported the review included budget account and reserve fund designations, special tax rates, benefit assessment rates for Zones A, B, and C, and reserve fund transfers. Additional copies of the draft budget were presented to each present Trustee. There was no action required.

Work Completed:

CONTINUATION OF SWIMMING POOL INSPECTIONS ON PROPERTIES IN FORECLOSURE

The District continues to work with the County Assessor's office and the County GIS Department to develop a list of properties with swimming pools that are either in default or full foreclosure. There were 15 pools on the June pool list, up from 10 in May.

FIELD ACTIVITIES

Mosquito activity and control work increased significantly in June as expected. As of the end of June, West Nile virus (WNV) had not been detected in the human or mosquito population. WNV was detected the first week of June in 2014, putting us several weeks later in terms of initial detection this year. The District's aerial adulticide contractor completed two spray missions, treating 23,200 acres throughout the Delta (Empire Island, King Island, Wright Tract, Rindge Tract, portions of Shima Tract Terminous and Shin Kee) in response to high mosquito trap counts. Aerial larviciding of rice fields increased to 9,200 acres and will continue through July and August until fields begin draining in preparation for harvest. Field Technicians saw increased mosquito breeding activity in pastures, dairy ponds/drains, Irrigation ponds/drains, wetlands and a variety of urban sources. Staff continued to treat unmaintained swimming pools identified from the aerial photographs in May.

CATCH BASIN TREATMENTS

Catch basins were treated with a long-term residual Methoprene product in June. The briquets slowly release the Insect Growth Regulator at an efficacious rate for approximately 90 days. Staff will collect pupa samples on a monthly basis and check for adult emergence to ensure the product is still working and to help determine if another basin treatment will be required in the early fall.

Monthly Activities:

- Two presentations were given on basic mosquito biology, invasive species, and emerging diseases. The presentations were given to the Lockeford Municipal Advisory Council and the San Joaquin County Environmental Health Department.
- San Joaquin Magazine features our ½ page advertisement on “District Services” in the July issue. This high quality print magazine is found in many offices and restaurants throughout San Joaquin County.
- The District’s 30 second radio ads are continuing to run on KJOY, KATM, KWIN, KWNN, and KHKK. The ads are also running on streaming radio reaching those who listen to the radio via their desk top computer, tablets or handheld devices. The ad schedules are reconciled against the contract on a monthly basis.
- During National Mosquito Awareness week, June 23 through June 26, the District gave mosquitofish out to residents of San Joaquin County. We advertised on a digital billboard for the first time at Arch and Airport Way. We had advertisements in the Record, Lodi News Sentinel, Ripon Record, Manteca Bulletin, Manteca Bulletin Extra, Escalon Times, Tracy Press and the Latino Times. I asked each city to post the fish giveaway information on their websites. I also interviewed on KJOY radio regarding the event. OES ran a social media campaign through their office, helping to bring more people to the event locations.
- The mosquitofish giveaway ended with the following people receiving mosquitofish per city; Stockton 42, Lathrop 6, Manteca 15, Ripon 6, Escalon 6, Tracy 6, and Lodi 29. For the seven cities and surrounding areas a total of 110 people received mosquitofish and two requests for additional service were taken. With each container of fish, people received a brochure on mosquitofish, a small bag of fish food and a sample packet of DEET.
- During the month, the District ran ads on KCRA. The television ads encourage draining water and using repellents. A total of 20 commercials ran during the month.
- The District’s website was updated with Board minutes, agenda and news releases including news alerts. For the period of June 1 to June 30, the website had 6,589 visitors, averaging 219 visitors per day. The web visitors, viewed a total of 7,623 website pages. Some broken links on the website were repaired.
- During the month I interviewed with Univision television, The Manteca Bulletin, Ripon Record, Lodi News Sentinel, Capitol Public Radio and KAT Country Radio. We have several pre-giveaway mosquitofish articles, followed by articles after the event. One article was on the front page of the paper.
- I sent two news releases. One release was to report three WNV positive mosquito samples and one WNV positive bird. The other news release announced the mosquitofish giveaway. During the month three spray alerts were also sent. A total of 1,541 recipients were sent the email notification with a 33% unique open email rate.
- I completed the four panels, 4-color tick brochure. Please see attached.
- I worked with GovDelivery to improve the tracking analytics of our email notification system.
- I continue to order safety supplies for both the Stockton and Lodi Yard. I also worked with ZEE to update first aid boxes at the Stockton office. I worked with several employees in safety training,
- During the month I completed the mosquito test questions for the District’s website and identified photos for each questions.
- **Scheduled Tasks for July:** Complete the mosquito quiz and work the second quiz of three. Reconcile all media that is running for the month. Report news and spray alerts as needed. Rewrite the Cumulus radio ads for better relevance at this time of year.

MANAGER'S REPORT

For the period June 11, 2015 through July 14, 2015

- The process continued on the sale of 200 N. Beckman Rd. At the June 2015 BOT meeting, Jim Martin, assigned Broker of Lee & Associates, informed the Board that the buyer is moving forward with the Phase II investigation and hired a firm to complete the initial boring on designated sites of concern. Following the BOT meeting, I received contact from Mr. Martin that the buyer was requested (per loan requirements) to obtain an updated Environmental Site Assessment I (ESA I) since the current ESA I exceeded a six month period. The original ESA I was completed on September 12, 2014. I initially argued that there has been no change of use on the property (vacancy); therefore, I could not foresee a change in the current environmental conditions. Mr. Martin stated one of the lenders (Small Business Administration-SBA) identified a new guideline for 2015; whereby, they cannot accept an ESA I report more than six months old. I worked with Neil O. Anderson and Associates to produce an updated ESA I at a reduced rate, with the thought process we would have this for use through the end of this calendar year, should this current sale fail.
The Assistant Manager and I were on site during the boring work completed by the buyer's Phase II contractor. Three sites were designated for boring analysis. One site in the shop approximately 3 feet west of the hydraulic lift, the second site approximately 70 feet east of shop building located under the car port, and the third site approximately 70 feet east of that, also located under the carport. The work was completed in one day, and we are awaiting final results from the soil sample analysis. Jim Martin and I amended the "Offer to Purchase and Contract of Sale" to reflect the close of escrow on July 31, 2015. More detailed information will be discussed during the Board meeting. Agenda item # 4. (Attachment)
- Emily Nicholas and I finalized the 2015/16 budget included in this packet. On the income side, we have continued the current benefit assessment at the same rate as 2014/15, which has been included in the engineer's report from SCI. We also completed the special tax rates and use code assignments for 2015/16. Additionally, we have been informed by the County Administrator's office that projected property tax revenue will increase by approximately 5%; therefore, justifying freezing the current Benefit Assessment rate for this fiscal year. The full budget will be presented and acted on by the Board at the July 2015 Board meeting, Agenda Items #4, #6, and #7.
- Emily Nicholas and I met with an insurance broker from Keenan and Associates to compare current District Dental and Vision plans to other options that are provided by Keenan. Proposed options include our existing plans as well; however, offered at a lower monthly premium. We will continue our investigation and I will have a general staff meeting so as to keep the employees informed on any changes we may be considering.
- I met with Jim Mulrooney of Mulrooney Auction Company to facilitate the sale of surplus equipment approved for sale at the April 2015 BOT meeting. The sale is scheduled for July 18th, 2015 in Thornton, CA.
- The District received two (2) public records requests during this time period from former District employee Tiffany Anderson. Copies of the requests are provided under the correspondence section of your Board packet. All information provided is on file and available for the Board's review.

Dear Ms. Anderson,

I am in receipt of your request for information for the wage and benefit history for some current and prior District employees.

Please understand that the District is obligated to make available for your inspection or to provide copies of documents that are in existence and responsive to your request. The District is not obligated to create new documents nor is it obligated to provide narrative responses to questions. In addition, the District is not obligated to post your requested information on the District's web-site.

The District will not produce records that are privileged unless such privileged information can be redacted so as to provide relevant information. The District will provide the records that are available; however, you seek information on some individuals last employed more than a decade ago. It will take additional time to find and copy those records. 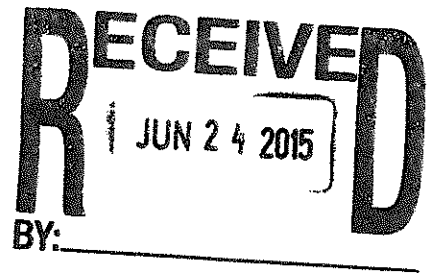

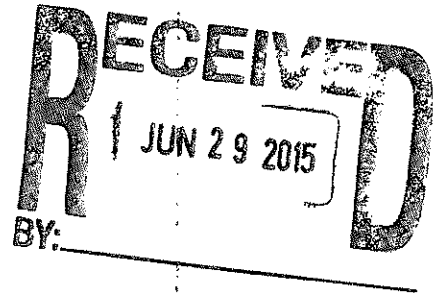

 - b) Copies of contract, budgets and invoices for each of the companies in item 1 a);
 - c) Dates of implementation and "retirement" for each device, with an explanation as to why they were decommissioned, unless still in use;
 - d) Names of any Mosquito District employees who conducted training for any of the devices named above, as well as their salary deferential or bonus for serving as such, if any, and the training dates for which they were involved.

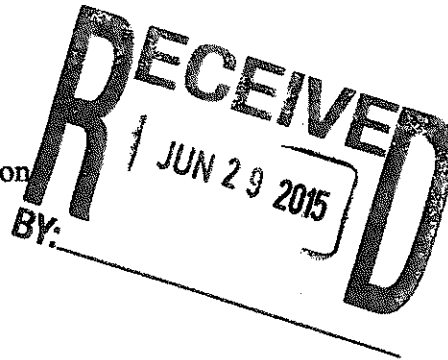



5. The hearing will then be opened to the public for comments and questions regarding the staff report. Any member of the public is encouraged to speak or provide written comments. We request that any comments be limited to 5 minutes.
6. Following the public comment period, the **President** will close the public hearing and the matter will be brought back to the attention of the Board. The **Board** can consider the proposed assessment per Resolution 15/16-02 (Agenda Item 6).

STAFF REPORT FOR AGENDA ITEM 5: Public hearing for the proposed Mosquito, Vector and Disease Control Benefit Assessment for Fiscal Year 2015-16

PRESENTED BY: District Manager Eddie Lucchesi

BACKGROUND:

Resolution 14/15-09, adopted by the Board of Trustees June 16, 2015, approves the intention to levy assessments for fiscal year 2015-16, preliminarily approving the engineer's report, and providing for notice of public hearing for the District's Mosquito, Vector and Disease Control Assessment. If adopted, Resolution 15/16-02 approves the Engineer's Report and orders the levy of the assessment on the basis of single family equivalent (SFE), at the rates of: Zone A-\$8.42 /SFE, Zone B-\$8.00/SFE, and Zone C-\$8.85/SFE; the maximum rate for any zone is \$9.40/SFE.

In 2005, the District's property owners approved a yearly fee of \$7.58/SFE for the Mosquito, Vector and Disease Control Assessment by 71.41% of the weighted ballots. Included in the voter approval was an inflation escalator allowing for a 3% per year inflationary increase to the assessment. State law requires the District to renew the base assessment and any inflationary increase each year through a public hearing process.

The Board of Trustees is now conducting a public hearing to consider the assessments for fiscal year 2015-16 to fund its programs and services. The District provides services and programs for disease and vector surveillance, disease prevention, control of vectors using integrated pest management methods and quality assessment. The mosquito abatement, vector control, and disease prevention projects and programs include, but are not limited to, source reduction, ground and aerial surveillance and control applications, disease monitoring, public education, quality control and applied research as well as maintenance of buildings, grounds and equipment and operating expenses. The District's services encompass approximately 1,400 square miles and are provided to properties accommodating approximately 690,000 residents. The majority of the District's funding is generated by a percentage of the 1% property tax collected from San Joaquin County property owners. Any property owner who feels that the assessment levied on the subject property is in error as a result of incorrect information being used to apply the foregoing method of assessment, may file a written appeal with the District's manager or his or her designee. Any such appeal is limited to correction of an assessment during the then current Fiscal Year or, if before July 1, the upcoming fiscal year.

In each subsequent year for which an assessment will be continued, the Board must:

- Preliminarily approve at a public meeting a budget for the upcoming fiscal year's costs and services;
- Preliminarily approve at a public meeting an updated annual Engineer's Report;
- Provide an updated assessment roll listing all parcels and their proposed assessments for the upcoming fiscal year;
- Call for the publication in a local newspaper of a legal notice of the intent to continue the assessments for the next fiscal year and set the date for the noticed public hearing.

At the annual public hearing, members of the public can provide input to the Board prior to the Board's decision on continuing the services and assessments for the next fiscal year. The yearly assessment is subject to an annual adjustment tied to the Consumer Price Index for the San Francisco Area as of December of each succeeding year (the "CPI"), with a maximum annual adjustment not to exceed 3%. The yearly assessment rate per single family equivalent (SFE) benefit unit for the Mosquito, Vector and Disease Control Assessment may increase in future years by an amount equal to the annual change in the CPI, not to exceed 3% per year. In the event that the annual change in the CPI exceeds 3%, any percentage change in excess of 3% can be cumulatively reserved and can be added to the annual change in the CPI for years in which the CPI change is less than 3%. The assessments for FY 2014-15 were levied at the yearly rates of \$8.42 (Zone A), \$8.00 (Zone B), and \$8.85 (Zone C) per SFE as described in the Engineer's Report for fiscal year 2014-15 with estimated total annual revenue of approximately \$1,881,310

The fiscal year 2015-16 assessment budget includes:

- Mosquito and vector surveillance, control and abatement
- Surveillance and testing for vector-borne diseases
- Rearing and distribution of mosquitofish
- Public outreach and education

The annual CPI change for the San Francisco Bay Area from December 2013 to December 2014 was 2.67% and the Unused CPI carried forward from the previous fiscal year is 0.00%. Therefore, the maximum authorized assessment rates for fiscal year 2015-16 is increased by 2.67% which equates to \$9.40/SFE, which is less than the 3% maximum allowed annual increase. The maximum CPI increase that can be used in fiscal year 2015-16 is 3%.

MANAGER'S RECOMMENDATION:

I recommend the acceptance and adoption of Resolution 15/16-02, which continues the benefit assessment rates of \$8.42 (Zone A), \$8.00 (Zone B), and \$8.85 (Zone C) per single family equivalent family unit, in order to properly finalize and adopt the assessment proceedings accordingly defined in Proposition 218. As stated earlier in this report, these rates are below the maximum authorized assessment rate of \$9.40/SFE.

FISCAL IMPACT:

By ordering the levy of assessments the District will receive an amount approximated at \$1,906,779 for the fiscal year 2015-16 budget.

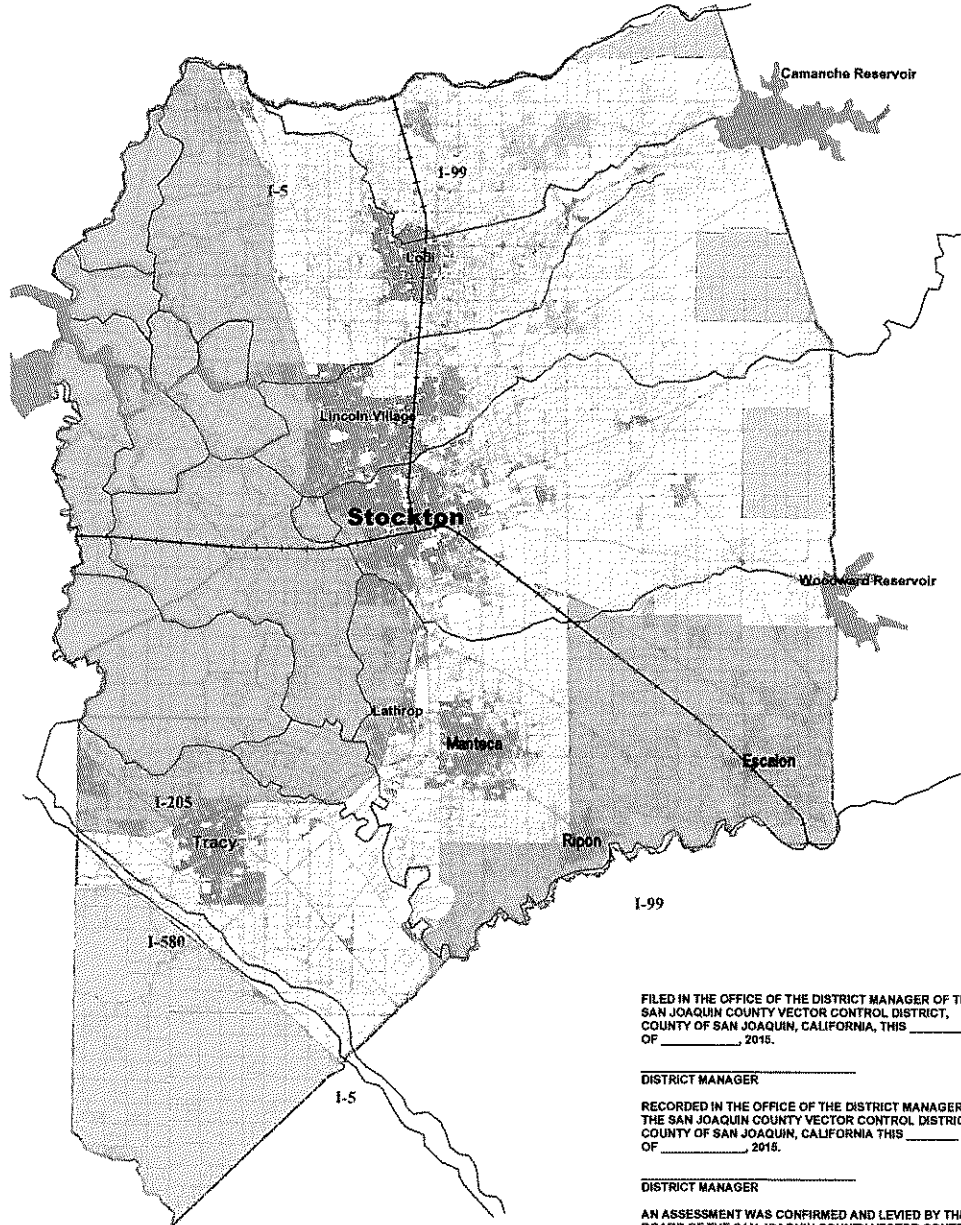

On June 16, 2015 the Board adopted Resolution 14/15-09, a resolution of intention to continue the assessments for Fiscal Year 2015-16, preliminarily approving the engineer's report, and providing for notice of hearing for the District's Mosquito, Vector and Disease Control Assessment; this resolution was unanimously approved.

On July 21, 2015, the Board will conduct a public hearing regarding the proposed Mosquito, Vector and Disease Control Assessment for the San Joaquin County Mosquito and Vector Control District. The public hearing will be held following public notice as required by state law governing the procedures for a proposed continuation of benefit assessment charges.

If there is no majority protest to the assessment at the public hearing, it is recommended that the Board approve Resolution 15/16-02 to order the continuation of the assessments for the Mosquito, Vector, and Disease Control Assessment. The proposed assessments will generate an estimated \$1,906,779 for fiscal year 2015-16. In future years, the assessments can be continued and the rate of assessment can be increased by the annual change in the San Francisco-Bay Area Consumer Price Index, not to exceed 3% per year, following the preparation of an updated Engineer's Report and the Board's conducting a public hearing on the continuation of the assessments.

If approved by the Board, Shilts Consultants, Inc. will coordinate with the San Joaquin County Auditor/Controller in filing the assessments for Fiscal Year 2015-16. Shilts Consultants, Inc. and the San Joaquin County Mosquito and Vector Control District's manager will also file copies of the Assessments and other necessary documents with the County Auditor. The first proceeds from the assessments would be disbursed by the County Auditor/Tax Collector in late December 2015 or early January 2016.

WHEREAS, the San Joaquin County Mosquito and Vector Control District ("District") is authorized, pursuant to the authority provided in Health and Safety Code Section 2082 and Article XIII D of the California Constitution, to levy assessments for mosquito, vector and disease control projects and services; and

WHEREAS, such mosquito, vector and disease control services provide tangible public health benefits, reduced nuisance benefits and other special benefits to the public and properties with the areas of service; and

WHEREAS, an assessment for mosquito, vector and disease control services has been given the distinctive designation of the "Mosquito, Vector, and Disease Control Assessment" ("Assessment"), and is primarily described as encompassing the boundaries of San Joaquin County; and

WHEREAS, the Assessment was authorized by an assessment ballot proceeding conducted in October and November 2005 and approved by 71.41% of the weighted ballots returned by property owners, and such assessments were levied by the Board of Trustees of the San Joaquin County Mosquito and Vector Control District by Resolution No. 05/06-05 passed on November 15, 2005;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the San Joaquin County Mosquito and Vector Control District that:

SECTION 1. SCI Consulting Group, the Engineer of Work, prepared an engineer's report in accordance with Article XIII D of the California Constitution and Section 2082, et. seq., of the Health and Safety Code for the Assessment (the "Report"). The Report have been made, filed with the District and duly considered by the Board and is hereby deemed sufficient and approved. The Report shall stand as the Engineer's Report for all subsequent proceedings under and pursuant to the foregoing resolution.

SECTION 2. On June 16, 2015, this Board adopted Resolution No. 14/15-09 to continue to collect Assessments for fiscal year 2015-16, preliminarily approving the Engineer's Report, and providing for notice of hearing on July 21, 2015 at the hour of 1 o'clock p.m. at the San Joaquin County Mosquito and Vector Control District Office located at 7759 South Airport Way, Stockton, California.

SECTION 3. At the appointed time and place the hearing was duly and regularly held, and all persons interested and desiring to be heard were given an opportunity to be heard, and all matters and things pertaining to the continuation of Assessment were fully heard and considered by this Board, and all oral statements and all written protests or communications were duly heard,

considered and overruled, and this Board there by acquired jurisdiction to order the continuation of assessment prepared by and made a part of the Engineer's Report to pay the costs and expenses thereof.

SECTION 4. The above recitals are true and correct.

SECTION 5. The public interest, convenience and necessity require that the continuation be made.

SECTION 6. The Engineer's Report for the Assessment together with the proposed assessment roll for fiscal year 2015-16 is hereby confirmed and approved.

SECTION 7. That based on the oral and documentary evidence, including the Engineer's Report offered and received at the public hearing, the Board expressly finds and determines that: (a) each of the several lots and parcels of land subject to the Assessment will be specially benefited by the services to be financed by the assessment proceeds in at least the amount of the assessment apportioned against such lots and parcels of land, respectively; and (b) that there is substantial evidence to support, and the weight of the evidence preponderates in favor of, said finding and determination as to special benefit to property from the mosquito, vector and disease control services to be financed with assessment proceeds.

SECTION 8. That assessments for fiscal year 2015-16 shall be continued at the rate of EIGHT DOLLARS AND FORTY-TWO CENTS (\$8.42) for Zone A, EIGHT DOLLARS AND ZERO CENTS (\$8.00) for Zone B, and EIGHT DOLLARS AND EIGHTY-FIVE CENTS (\$8.85) for Zone C, per single family equivalent benefit unit as specified in the Engineer's Report for fiscal year 2015-16 with estimated total annual assessment revenues as set forth in the Engineer's Report; and

SECTION 9. That the mosquito, vector and disease control services to be financed with assessment proceeds described in the Engineer's Report are hereby ordered.

SECTION 10. No later than August 1st following such adoption, the Board shall file a certified copy of the diagram and assessment and a certified copy of this resolution with the Auditor of the County of San Joaquin ("County Auditor"). Upon such filing, the County Auditor shall enter on the County assessment roll opposite each lot or parcel of land the amount of assessment thereupon as shown in the assessment. The assessments shall be collected at the same time and in the same manner as County taxes are collected and all the laws providing for collection and enforcement shall apply to the collection and enforcement of the assessments. After collection by the County, the net amount of the assessments, after deduction of any compensation due the County for collection, shall be paid to the Mosquito, Vector and Disease Control Assessment.

SECTION 11. All revenues from Assessments shall be deposited in a separate fund established under the distinctive designation of the San Joaquin County Mosquito and Vector Control District Mosquito, Vector and Disease Control Assessment.

SECTION 12. The Assessment, as it applies to any parcel, may be corrected, cancelled or a refund granted as appropriate, by order of the Board of Trustees of the District. Any such corrections, cancellations or refunds shall be limited to the current fiscal year.

8. STATUS ON SALE OF SURPLUS DISTRICT PROPERTY, 200 N BECKMAN RD, LODI, CA
Report on progress as it pertains to sale of property.

At the June 2015 BOT meeting, Jim Martin, District real estate broker (Lee & Associates), reported the lender is requiring the buyer to have a Phase II report conducted to evaluate potential petroleum hydrocarbons that may have leaked from the hydraulic lift located in the shop. The buyer contracted with an engineering firm to complete the Phase II investigation at the buyer's expense. In addition; immediately following our Board meeting, I received information from Mr. Martin that one of the buyer's lenders requested an update on the ESA I, per 2015 guideline changes, that states they cannot accept Phase I reports older than six months. The original ESA I was completed in September of 2014.

I worked with Neil O. Anderson and Associates to conduct an expedited ESA I update, which was completed at half the cost of the initial ESA I. In discussing this issue with legal counsel Eley, it was determined the District may need an updated ESA I as required, should this sale fail and we collaborate with a new buyer. The District has received the most recent ESA I report with a copy provided to the buyer. The buyer's Phase II on-site boring work was completed, and it is anticipated the Phase II full report of findings should be available in time for review at the Board meeting.

As discussed at the June BOT meeting I worked with Mr. Martin to amend the "Offer to Purchase and Contract of Sale" to reflect Friday, July 31st, 2015 as the close of escrow.

The Manager and Jim Martin will provide the Board with the most recent information on the progress regarding the Phase II report and other updates on the sale of the property.



9. RESOLUTION 15/16-04, A RESOLUTION OF THE BOARD OF TRUSTEES OF THE SAN JOAQUIN COUNTY MOSQUITO AND VECTOR CONTROL DISTRICT ADOPTING A PAID SICK LEAVE POLICY PURSUANT TO AB 1522 FOR PART-TIME, TEMPORARY AND SEASONAL EMPLOYEES

On September 10, 2014 Governor Brown signed into law the Healthy Workplaces, Healthy Families Act of 2014 that provides three (3) days of paid sick leave for eligible employees beginning July 1, 2015. Effective January 1, 2015, employers were required to post information about AB 1522; however, the paid sick leave provisions do not go into effect until July 1, 2015. AB 1522 sets forth the conditions and purposes for which paid sick leave is to be provided.

On July 1, 2015, the State of California enacted the Healthy Workplaces, Healthy Families act of 2014 (AB 1522); whereby, employers must provide paid sick leave for employees covered under AB 1522. The current District employee position covered by AB 1522 would be the position of District Utility Worker, which is a seasonal position. The District provided these effected employees a memo recognizing the requirements of the District to implement AB 1522, and the method to be used in the implementation process.

Under the provisions of AB 1522, the District may establish the accrual method and the minimum usage increment for paid sick leave. Under the proposed method of implementing this benefit, part-time employees will be credited with twenty four (24) hours of sick leave after working 90 days with the District. Any unused sick leave will carry over into a new fiscal year. Employees who have not worked in a 12 month period shall be considered a new employee for purposes of sick leave accrual and usage.

A draft resolution (Resolution 15/16-04) will be presented to the Board for adoption. Attached to the resolution is the draft amendment (Exhibit "A") that includes the provisions of AB 1522 to the District's current sick leave policy.

WHEREAS, on September 10, 2014 the Governor of the State of California signed the Healthy Workplaces, Healthy Families Act of 2014 (AB 1522) providing paid sick leave for covered employees effective July 1, 2015; and

WHEREAS, the AB 1522 paid sick leave provisions are to take effect July 1, 2015; and

WHEREAS, the District wishes to establish a paid sick leave policy pursuant to AB 1522 for part-time, temporary, and seasonal employees; and

WHEREAS, part-time, temporary, and seasonal employees are not covered by any existing collective bargaining agreement, benefits resolution nor any other benefits policy; and

WHEREAS, AB 1522 allows the District to establish the accrual method and minimum usage increment for paid sick leave;

NOW, THEREFORE, BE IT RESOLVED, that the Trustees of the San Joaquin County Mosquito and Vector Control District hereby adopts the provisions under the District's Sick Leave Policy for Part-Time, Temporary and Seasonal Employees shown as Exhibit "A" to this resolution.

5004 Sick Leave

Sick leave is a form of insurance that is accumulated in order to provide a cushion for incapacitation due to illness. It is used only when actually required to recover from illness or injury; sick leave is not for “personal” absences. Time off for medical and dental appointments will be treated as sick leave. Abuse or misuse of your sick leave privilege will not be tolerated by the District.

The District offers paid sick leave to eligible employees. You accrue paid sick leave at the rate of 13 days per year. Accrued sick leave does carry over from year to year. The District does provide pay in lieu of unused sick leave per the most current collective bargaining agreement or policy.

If you are absent due to illness, medical evidence of your illness and/or medical certification of your fitness to return to work satisfactory to the District may be required. If there is reason to believe that sick leave has been misused, you may be subject to disciplinary action.

Effective 7/1/2008:

Employees shall be entitled to use one-half (1/2) of their annual sick leave accumulation (as of 7/08 the annual sick leave accumulation is 13 days per calendar year) to attend to an illness of a child, parent, spouse, or domestic partner of the employee. The use of family sick leave shall comply with California Labor Code Section 233. (7/08)

Effective 7/1/2015 (AB1522)

Part –time, temporary, and seasonal employees who work 30 or more days a year are entitled to paid sick leave to be accrued at a rate of no less than one hour for every 30 hours worked. Accrued sick leave shall carry over from year to year up to a maximum of six (6) days or forty-eight (48) hours. Employees may begin using accrued leave on the 90th calendar day of employment. Use of paid sick leave is limited to three (3) days or twenty-four (24) hours per fiscal year. Paid sick leave must be used in a minimum increment of two (2) hours per each occurrence. Unused, accumulated sick leave hours are not compensable if an employee separates from District

employment. If an employee is re-hired within one (1) year of separation, previously accrued and unused paid sick leave hours will be restored. In the event a part-time or seasonal employee is hired for full time employment, the employee will fall under the provisions of the sick leave accrual for full time employees and will be considered separated from part-time / seasonal employment and the provisions of AB 1522. (7/15)
