## **Email**

John,

I spoke with Emily this morning after receiving your response last night. Emily informed me you never informed her to send the documents to me. I have financial obligations that I am responsible for. I have been waiting 8 days for the documents from UNUM to arrive. When Emily and I spoke she informed me that it is the initiative of the employee to request the forms. UNUM is notorious for slow processing, which means I am going to be in financial dire.

As far as AIMS is concerned it has been 55 days since my injury. Not a scratch as both you and Eddie have defined it, a open wound 18 cm in length with a external bruise from my ankle to my thigh. If you would have reported the injury to AIMS the day I filed the DWC form I would not be in in this situation right now. Instead you paid out of the Districts funds and neglected to inform your insurance carrier. Dr. Eck's demeanor was nervous, he couldn't get me out of his

office fast enough. I believe foul play was involved with my visit's to US Health Works. With the length of my cut and the bruise that went from the bottom of my leg to the top of my thigh how could Dr. Eck determine I was a first aid case.

Unaware AIMS had not been notified I have correspondence to Mackenzie stating after working on catch basins and then returning for cold fogging my knee hurt so bad I wanted to go to the emergency room. Is that the sign of a scratch?

I have been in constant communication with Mackenzie via email and phone conversation. I believe I have completed and returned all documents that was requested of me. Roberta from Dr. Murata's office at 946-7123 informed me Mackenzie was going to fax a report request on Monday August 26,2011. Today I followed up with Roberta and Mackenzie failed to follow through.

I feel like I am getting the run around from you and AIMS.

As far as the exposure goes I met with the state work comp board and they instructed me to file a second DWC form for the pasture water that entered my wound. If you reimburse my sick days July 26,27,28,29 and honor the time I was required by you to use my vacation time for my work comp Dr. appointments I will not file the second DWC form for exposure.

Again I will reiterate I did everything I knew to do

regarding reporting my injury. Showed my supervisor the injury, sat down and wrote an incident report with my supervisor, requested to see a doctor when I felt it was necessary.

This is a short version of what is to come. If you truly want to help me, get your adjuster to accept my claim. This was an accident and that is what insurance is for.
