John,

It boggles my mind that a claim that was filed on July 1, 2011 is still pending. How can that be?

My first concern with this claim is Dr Eck himself. His demeanor was curt and he was very nervous in my presence. Then as I go over my medical records I requested from my two visits from US Health Works I discover both visits were paid out of the Districts personal funds, my injury was never reported to your insurance carrier and it appears there were never any intentions to report my injury to AIMS.

I followed District protocol. Due to the fact that my injury happened at the end of the work day I did not file the DWC form, I did however show my supervisor immediately before I left for the day. I had to request to file the DWC form. My supervisor should well versed in handling on the job injuries and how important it is for the Districts liability as well as the well being of the employee. After all you have brought this subject up to all employees in multiple general meetings.

Unaware that Mackenzie Dawson had not been notified regarding my new injury I sent her an email July 13, 2011 informing her I was in severe pain and that by the end of my shift I felt as if I could go to the emergency room.

The week prior to Monday July 18, 2011 I inspected and treated irrigated pastures on the C line. I could feel the dirty water entering my wound and burning me. On Monday I was feeling symptomatic and I requested our Assistant Manager Eddie Luchessi to send me back to US Health works. Eddle started to verbally attack me and informed me that I was a constant problem and had issues every two weeks. The issue he mentioned was my informing my supervisor Brian Heine that I had a source card in my zone that served as a registered half way house for child molesters and a rapist. Parcel #24919020 @ 29363 E River Road Escalon CA 95320. Eddle told me I wasted Brian's time sending him out to the property. When all I had done was communicate to Brian that the property owner Craig Whitcomb at Parcel #24919018 @21696 S Santa Fe Escalon CA 95320 instructed me not to enter that property. You, John are always reiterating to the technicians to communicate with our supervisors. This incident happened two weeks prior. Eddie chose this time when I was sick and asking for medical attention to verbally attack me in a hostile manner.

7/18/11 After visiting Dr. Eck who was paid by the District and again unreported to AIMS the Districts insurance carrier I was sent away with my symptoms ignored. The symptoms I stated were I called in sick the next 4 days and took it upon myself to see my own doctor who prescribed antibiotics. Four days of my accrued time, time that has now been used against me on my most current evaluation.

My symptoms have ranged from sore throat, nausea, hot flashes, cold chills, open wounds in my mouth under my tongue, headache, fever, dizziness, pain in my lymphatic system, neck, arms, shoulders. These symptoms have persisted since Monday July18, 2011 and have not subsided. You state that a second DWC form is not necessary although it contradicts the State Comp Board recommendation. I am seeing Dr. Murata who is a orthopedic surgeon. Dr. Murata does not deal with the symptoms mentioned above.

What concerns me the most of all that has transpired is the verbiage both you and Eddie have used in regard to my injury. Referring to it as a mere scratch. It was an open wound to my right knee that started from the bottom scar from my post surgical wound. The wound was 18 cm in length. I had a bruise from the front of my ankle all the way up to my thigh. Dr. Eck would not know this because my pants could only fold up to my knee. I was not asked by the doctor to put on a gown so he could see the full extent of the injury, along with protocol of having a nurse in the room to witness the examination. Of course it is my opinion it was only his job to get me out of his office as fast as he could.

I do not need you to clarify to me the terminology of a claim assignment and an accepted claim. I understand fully. I understand you have not followed protocol when it comes to reporting injuries to your insurance company. I understand you had no full intentions of accepting my claim.

Regarding past claims and compensation in regards to my exposure cases I never asked for gas money reimbursement I never received a settlement and the majority of the time off for those claims were taken from my sick bank, which later were used against me on my evaluations.

I did receive UNUM documents from Emily, please tell her thank you.

In regards to any discussions between you and I as I stated to Michelle Morgan over the phone the day I informed her I wanted to file the DWC for the illness but I wanted her to tell you, you scare me. Thank you for offering to be available but if you, Eddie or I have any communication I
