On Sep 14, 2011, at 5:44 PM, Mackenzie Dawson wrote: Tiffany I received your voicemail and email today. I have already called and left you a return voicemail but thought I would follow up with an email.

I feel the need to respond to this email. In your wording you make it sound as if I made threats to you. Those are harsh and inaccurate accusations

First off, if you truly believe I threatened you in any way, please keep a copy of the phone message I left, just in case this is brought up again.

I was unaware that you were on vacation or that you were sick. It had been four weeks since I had been placed on modified duty by Dr. Murata without accommodations by my employer.

In the message I left for you that you deemed threatening, my words were this: Mackenzie I am keeping an excel spreadsheet of the dates and times I call you or send emails without hearing a response to show in court if necessary. I respectfully disagree that my statement was threatening, but yet an act of accountability and the only power I have over my circumstances.

I don't find it appropriate that you are making threats against me for not being responsive as I have kept you up to date on the status of your claim thus far. I was out ill and on vacation last week which is why it has taken me a couple of days to get back to everyone.

I apologize for going over your head and speaking to your supervisor. In my defense the many attempts I made to my employer regarding the Injured Worker Salary Continuation and to AIMS is less than I would be receiving from my debtors if I did not take action.

I also know that you called this morning and spoke to Kim here who did discuss your claims with you as well. I have also been informed that you have already contacted my attorney Eric Helphrey as well. To update you on what is going on with your claim letters will be coming out in the mail to you tomorrow.

I received a letter from Eric Helphrey yesterday, please note I am self represented and do not forward any further correspondence to Mr. Stein's office.

I am currently waiting for an updated wage printout from the district to calculate payments for you and am assured that I will have that tomorrow morning. As I indicated in my voicemail if you have any questions please feel free to contact me at 916-563-1900 X 242. Thanks
