Should you have further questions of me you are welcome to call. However, I would recommend that you send me a letter to ensure there is no confusion as to the specific questions or concerns that you may have.


Also, please be advised that you have the right to seek legal counsel and/or talk to the Information & Assistance Officer at (800) 736-7401.
