**ASSIGNMENT**

Our office received this case assignment on September 14, 2011. We were requested to conduct three to four days of surveillance in order to determine the Claimant's current level of activity.

**INVESTIGATION SUMMARY**

**On Wednesday, September 21, 2011, between the hours of 6:00 a.m. and 11:00 a.m.,** surveillance was conducted at Claimant's residence. Upon arrival, we observed the Claimant enter her vehicle then drive to the insured. We later learned that the Claimant was recently placed on modified duty at the insured. Upon learning this information, we ended our efforts.

**On Saturday, September 24, 2011, between the hours of 6:00 a.m. and 2:00 p.m.,** we began surveillance efforts at the provided address for the Claimant. An illuminated, interior light was observed to be on upon arrival and the Claimant's black Ford Mustang remained parked curbside in front of the residence. No activities to and from the residence were observed.

**On Saturday, October 1, 2011 between the hours of 6:55 a.m. and 2:55 p.m.,** the Claimant's vehicle was found to be parked on the roadside in front of the residence. Later in the day, the Claimant was observed arriving to her residence with an adult male driving a grey Chevrolet Corvette. Approximately 5 seconds of video of the Claimant walking into her residence after arriving as a passenger in a grey Corvette driven by an adult, Caucasian male was obtained. She did not display any apparent restriction or discomfort, and did not use any visible medical apparatus or device while conducting these activities.

**On Tuesday, October 4, 2011 between the hours of 5:40 a.m. and 7:00 a.m.,** the Claimant was observed departing her residence driving a silver Mazda 3 hatchback to the insured.

**On Saturday, October 8, 2011 between the hours of 8:00 a.m. and 12:00 p.m.,** the investigator found the Claimant to apparently remain at the residence throughout the morning, and out of view. Her vehicle remained in front of the residence throughout the day, and the garbage cans remained at the street. The Claimant's mother emerged in the late morning and retrieved the newspaper, and returned inside. Accordingly, no meaningful video opportunities were presented.

**INVESTIGATIVE PLAN OF ACTION**

We will continue to keep this case as an active file and follow up with your office to confirm any changes to the claim status.

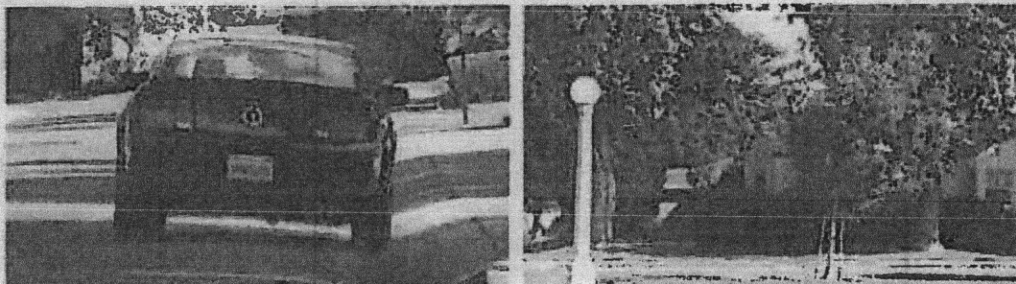

### SURVEILLANCE LOG

#### Wednesday, September 21, 2011

- 6:00 a.m. Surveillance efforts were initiated in the vicinity of 2 North Avena Avenue, Lodi, CA. A black Mustang, license plate 6HWR601, was parked in front of the home. Conditions were too dark at that time for any filming to take place.
- 6:20 a.m. The Claimant's Mustang lights flashed on and off, and the interior light went on several seconds later. The Claimant entered the vehicle and proceeded to drive to a Starbucks, where she drove through the drive thru window.
- 6:35 a.m. A visual of the Claimant's vehicle was lost as she entered an on-ramp for Highway 99 South.
- 7:35 a.m. A search for the Claimant's vehicle on the highway proved negative. Surveillance was then initiated within view of her workplace, where her vehicle was spotted in the building parking lot.
- 11:00 a.m. It was learned the Claimant had recently been placed on modified duty at the insured. Upon learning this, surveillance was discontinued.

#### Saturday September, 24, 2011



- 6:00 a.m. Surveillance efforts were initiated in the vicinity of 2 North Avena Avenue, Lodi, CA. The black Mustang bearing CA license plate 6HWR601 was parked in front of the residence and a single illuminated light in the home's interior was noted. Also noted to be parked on the side of the residence was a light blue Ford Taurus bearing CA handicap 8898H license plate. No activities were noted.

- 11:10 a.m. Through investigative efforts, the Claimant's presence was confirmed at the residence and surveillance continued.
- 2:00 p.m. The Claimant remained inside of her residence, and out of view. Surveillance was discontinued.

**Saturday October 1, 2011**

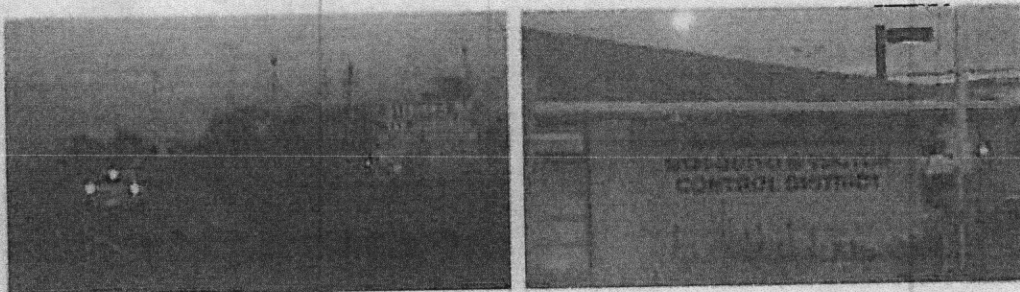


- 6:55 a.m. Surveillance efforts were initiated in the vicinity of 2 North Avena Avenue, Lodi, CA. The black Mustang bearing CA license plate 6HWR601 and a black Chevrolet Trailblazer bearing CA license plate 5TGB725 were parked in front of the house. Also noted to be parked on the side of the residence was a light blue Ford Taurus bearing CA handicap 8898H license plate. No activities were noted.
- 7:12 a.m. An adult female weighing approximately 200 lbs and standing approximately 5'6" departed the residence driving the blue Ford Taurus.
- 10:41 a.m. The Claimant and an adult male driving a Chevrolet Corvette bearing CA license plate 6MNH734 arrived to the Claimant's residence. The Claimant and this male then walked toward and into her residence, out of view of the investigator. It should be noted that this was the first sight of the Claimant on this day.

- 12:20 p.m. The adult male driving the Corvette, emerged from the residence alone and departed the area without the Claimant.
- 1:26 p.m. A teenaged male presumed to be the Claimant's son was observed gathering a guitar case from the Ford Mustang parked in front of the Claimant's residence before walking to a residence in the Claimant's neighborhood. The Claimant remained out of view.

- 2:15 p.m. The adult male driving the Corvette returned to the Claimant's residence. The Claimant remained out of view as this male entered the residence.
- 2:50 p.m. The adult male departed the Claimant's residence alone and the Claimant remained out of view.
- 2:55 p.m. The Claimant remained inside of her residence, and out of view. Surveillance was discontinued.

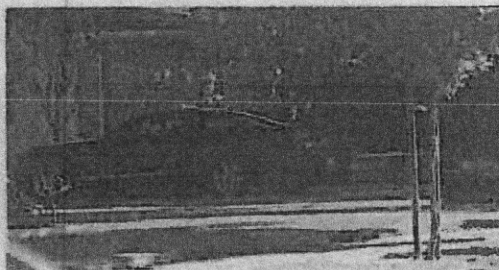
Tuesday, October 4, 2011



- 5:40 a.m. Surveillance efforts were initiated in the vicinity of 2 North Avena Avenue, Lodi, CA. The black Mustang bearing CA license plate 6HWR601 and was parked in front of the house. Also noted to be parked on the side of the residence was a light blue Ford Taurus bearing California handicap 8898H license plate
- 6:27 a.m. The Claimant departed her residence driving a silver Mazda 3 hatchback sedan bearing CA license plate 5USY931. This vehicle was found to be registered to David Jacob Smith.
- 6:50 a.m. The Claimant was observed arriving to her place of employment, Mosquito & Vector Control District located at 7759 South Airport Way, Stockton, CA.

- Upon arrival, the Claimant pulled into this facility which was found to be safely secured. A direct view of the Claimant or her vehicle was not feasible.
- 7:00 a.m. The Claimant remained inside the insured, and out of view. Surveillance was discontinued.

Saturday, October 8, 2011



- 8:00 a.m. Surveillance was begun in the vicinity of the Claimant's residence, located at 2 North Avena Avenue in Lodi, California. Upon arrival, the residence was dark inside, with no interior lights on, closed blinds, and no activity. The Claimant's black Ford Mustang was parked on the street in front of the residence, and the blue Ford Taurus, CA license plate 8898HDP was parked on the street next to the residence, and there were garbage cans at the curb. A secure surveillance position was established with the front of the residence, vehicles, and garbage cans in view.
- 10:31 a.m. A female believed to be the Claimant's mother emerged from the front door, and retrieved newspapers from the front porch. She returned inside, and out of view.
- 12:00 p.m. There was no activity about the residence. The Claimant remained inside, and out of view Surveillance was discontinued.
