4. Update RE: West Nile Virus Surveillance and Control

Manager Stroh gave an update on the status of West Nile Virus Surveillance and Control, including costs of surveillance and control since the August 2007 BOT meeting. Assistant Manager Lucchesi gave an update on the ground and air treatments involved with the West Nile Virus operations.

5. Request for Authorization to Expend/Transfer Funds from Restricted Reserve Account #5 (Public Health Emergencies) and to amend Specified Budget Accounts

Manager Stroh reported that due to higher-than-expected amounts (and costs) of mosquito surveillance and control operations during the period July 22<sup>nd</sup> through September 7<sup>th</sup>, the District had reached or exceeded budgeted amounts in several categories of the 2007-08 expenditure budget. To insure adequate cash flow and general fund levels through the end of the second quarter of the fiscal year, he recommended expend/transfer funds from the District's restricted reserve account #5. To date, he had expended \$374,242.24 (96.73% of budget) for aerial spraying, and \$1,267,876.82 (126.79% of budget) for agriculture chemicals to combat WNV per the District's IPM plan and the California Mosquito-Borne Disease Surveillance and Response Plan.

Additionally, he reported on the several awards that had been aggressively applied for and received from the California Department of Health Services-Vector-Borne Disease Section for local assistance funding for emergency mosquito control and West Nile virus surveillance, totaling \$676,852.35. Because these funds were supplemental to the District's existing expenditure budget and anticipated revenues, it was recommended to amend the 2007-08 budget in the following budget categories and amounts:

1)	#6221002 CONTRACT AIRCRAFT	\$186,140.72
2)	#6221504 LABORATORY EXPENSE	\$ 8,923.08
3)	#6255000 AGRICULTURE CHEMICALS	\$452,699.28
4)	#6451014 EQUIPMENT-FIELD	\$ 29,089.27

Following review and discussion, it was moved by Trustee Snyder, seconded by Trustee Groen, and unanimously passed to:

- 1) Authorize the expenditure/transfer of \$750,000.00 from the District's restricted reserve fund #5 to the general fund
- 2) For the March 2008 BOT meeting, consider returning general fund revenues to the restricted reserve fund #5
- 3) Amend the 2007-08 budget in the appropriate budget categories of #6221002-CONTRACT AIRCRAFT \$186,140.72; #6221504 LABORATORY EXPENSE \$8,923.08; #6255000-AGRICULTURE CHEMICALS \$452,699.28; AND #6451014-EQUIPMENT-FIELD \$29,089.27
