## FOURTH AMENDMENT TO

## THE PARVIN REVOCABLE TRUST, Dated May 30, 2002

- I, MARY JEAN PARVIN, the sole Trustor and Trustee under that certain Parvin Revocable Trust, dated May 30, 2002, (hereinafter, "the Trust"), hereby make the following amendments to the Trust, pursuant to Paragraph I of Chapter III:
- 1. Paragraph IV of Chapter IV, which has been mistakenly identified as Paragraph III in previous amendments, shall be amended in its entirety to read as follows:
  - "IV. <u>Distribution of Trust on Death of MARY JEAN PARVIN</u>: On the death of MARY JEAN PARVIN the Trustee shall administer and distribute the Trust estate as follows:
  - "A. TEN THOUSAND DOLLARS (\$10,000.00) to JIMMY AMBURN and BARBARA AMBURN, or the survivor of them, and if neither of them survive the Trustor, this gift shall lapse and become part of the remainder of the Trust estate.
  - "B. TEN THOUSAND DOLLARS (\$10,000.00) to RONALD EBEL, if he survives the Trustor, and if not, this gift shall lapse and become part of the remainder of the Trust estate.
  - "C. All of the rest, residue and remainder of the Trust estate shall be distributed to TIFFANY ANDERSON, if she survives the Trustor, and if not, to JIMMY AMBURN and BARBARA AMBURN, or the survivor of them."

Except as amended herein, all of the terms and conditions of the Trust, and as amended by the previous amendments to the Trust, where not inconsistent herewith, shall remain in full force and effect.
