I, SHIRLEY H. JOHNSON, a resident of San Joaquin County, California, declare this is my will.

ARTICLE I Revocation of Prior Wills

I revoke all Wills and Codicils to Wills that I have previously made.

ARTICLE II Family Declarations

I am a single person. I have no children living or deceased.

I declare it is my intention to dispose of all property I have a right to dispose of by Will.

ARTICLE III Payment of Debts

I direct my Executor hereinafter named to pay my last illness expenses, funeral expenses, and all my legally enforceable debts as soon as my Executor in their sole discretion determines can be conveniently made after my death.

ARTICLE IV Gift of Estate

I give all of my estate, both real and personal and wherever situated as follows:

- A. I give all of my jewelry, clothing, household furniture, furnishings, personal automobile, books and other tangible articles of personal nature together with any insurance on the property to those persons set forth in the Distribution of Personal property list which accompanies this Will. If there is no list, or if any item of personal property is not included on this list, then I give those items to MARY JEAN PARVIN if she survives me, and if not, to TIFFANY ANDERSON, if she survives me, to be distributed by her in her sole discretion to whomever she wishes including herself.
- B. I give all of the rest, residue and remainder of my estate, both real and personal and wherever situated to the Trustee then in office under that trust designated as the SHIRLEY H. JOHNSON REVOCABLE TRUST, as amended, to be administered as provided in that trust agreement I give all of my clothing, household furniture, furnishings, personal automobile, books and other tangible articles of personal nature together with any insurance on the property, in equal shares to my children who survive me, to be divided as they agree, and if they cannot agree, as my Executor shall determine.

If for any reason this disposition shall be ineffective or cannot be carried out according to its terms, I give the residue of my estate under and in accordance with the terms and provisions set forth in The SHIRLEY H. JOHNSON REVOCABLE TRUST, as amended, which terms and provisions I hereby incorporate by reference as if fully set forth herein.

ARTICLE V Executor(s)

I nominate MARY JEAN PARVIN as Executor of this Will. If MARY JEAN PARVIN shall for any reason fail to qualify or cease to act as Executor, I nominate TIFFANY ANDERSON, as Executor. The term "my Executor" as used in this Will shall include any personal representative of my estate. No bond shall be required of any person nominated in the Will whether acting jointly or severally in the administration of my estate.

I authorize my Executor to exchange or to sell, with or without notice, at either public or private sale, and to lease all or any portion of my estate, subject only to such confirmation as may be required by law and to administer my estate with full authority under the provisions of the California Independent Administration of Estates Act.

ARTICLE VI Disinheritance

Except as otherwise provided in this Will, I have intentionally omitted to provide herein for any of my heirs living at the date of my death.

ARTICLE VII No Contest Clause

I have intentionally and with full knowledge omitted to provide for my heirs, except for such provisions, if any, as are made specifically in my Will. If any person, who is or claims under or through a beneficiary of this Will or through my Trust, in any manner whatsoever, directly or indirectly, contests or attacks my Will or my Trust, takes any action that would frustrate the dispositive plan contemplated in my Will or my Trust, conspires or cooperates with anyone attempting to contest,

attack, or frustrate my Will or my Trust, or takes any of the actions set forth in items (a) through (d) below of this paragraph..., then in that event I specifically disinherit each such Objector. In that event, any portion of my estate not disposed of under the foregoing provisions of my Will or my Trust shall be distributed in the same manner provided herein as if that contesting beneficiary predeceased me. For purposes of this Part, the following actions shall constitute a contest: (a) filing a creditor's claim or prosecution of an action based thereon, (b) commencing any legal action or proceeding to determine the character of property, (c) challenging the validity of any instrument, contract, agreement, beneficiary designation, or other document executed by me and pertaining to the disposition of my assets (including the beneficiary designation of any annuity, insurance, policy, IRA, retirement plan, or buysell agreement), and (d) petitioning for settlement or for compromise affecting the terms of this Trust or my Will, or for interpretation of this Trust or my Will. Notwithstanding the foregoing but subject to paragraph 2 below, this paragraph 1 shall not apply to any person solely by reason of such person taking an action described in items (a) through (d) above, if such action is unopposed by my Executor or my Trustee.

ARTICLE VIII Miscellaneous

- A. As used in this Will, the masculine, feminine, or neuter gender, and singular or plural number shall each be deemed to include the others whenever the context so indicates.
- B. If any provision of this Will is unenforceable, the remaining provisions shall be carried into effect.
