With respect to your demand, obviously it is declined. While the District may be willing to settle out your claims, your demands are so unreasonable that it is impossible to provide you with a counter offer at this time. You have repeatedly referenced requiring compensation for your "pain and suffering." Please be advised that, under the Workers Compensation statutes, there is no remedy for pain and suffering. The benefits available are temporary disability, permanent disability, and medical care.

You are always welcome to avail yourself of the services provided by the Information and Assistance Office, whom you have met with numerous times before. They can certainly explain to you the benefits available under your Workers' Compensation claims. Perhaps such a conversation will help you to understand why your demands are not being met.
