To Whom It May Concern:

This communication is intended for all parties listed at the foot of this letter. Please update your records as to my current contact information.

I sustained nine injuries from my employment with the mosquito district. I had to undergo three knee surgeries. These surgeries led to my being removed from work. Being removed from work caused me tremendous financial hardships. The financial hardships forced me to relocate my residence five times. My past addresses were: Iris Drive, Sylvan Way, 2 N Avena, and 2120 Pine.

In 2009 my employer denied my injuries and without my consent or knowledge used up my vacation hours/sick bank. After that, I went without pay. I went without pay for five months while Assistant Manager Lucchesi tried forcing me onto state disability retirement.

During the last week in December of 2010, I was forced to move into a family member's home in deplorable conditions. When I left the Sylvan address I owed rent and utilities; these accounts went into collections. It's hard to move after a knee surgery but when you have no money it's the only option you have.

After moving into the Avena residence in 2010, the relative I moved in with had a stroke. This left me in a place where I couldn't leave. I had no money and my credit score pegged me as a risk and non-qualifier for renting.

I was forced to remain at the Avena address. I soon learned that the family member there had dementia. As the only other occupant of her home, I was forced to become her caregiver. When she died in November of 2015, I was forced to sell her home. My mother died a month later. All of the property taxes, homeowners insurance and mortgage payments went into default as I unable to keep the home that I inherited. I was forced to sell that house in August of 2015.

I relocated to a friend's house at 2120 Pine Street from August to October of 2015. My credit remained damaged from the years of lost wages. I couldn't qualify for a rental. After the house sold I was able to qualify to rent my own place and relocated to my current address.


This document is to inform all parties that I have suffered tremendous financial and emotional hardships. These even prevented me from some basic life requirements, including opening my mail immediately. Due to this, I have missed deadlines and hearings, sometimes by months.

I have been unable to attend physical therapy or attend doctor visits. It seemed to me that the opposing counsel has intentionally scheduled hearings and appointments with this knowledge that I shared with them.
