Pursuant to your demand letter of August 4, 2010, please find enclosed two sets of stipulations. The first is for the date of injury of June 19, 2008 at 4% permanent disability. The second is for the date of injury of March 26, 2009 at 2% permanent disability pursuant to Panel QME Dr. Tabaddor. This settlement also contemplates a future medical treatment award to your client's right knee only.

In addition, we are taking a credit for the temporary disability overpayment in the amount of \$4,571.42.


