Petitioner hereby requests that the above-entitled action be reopened for the following reasons:

I was previously represented by attorney Ronald Stein. I was scheduled to appear for a Status Conference before the WCAB on 3/8/2011 with my attorney. On the morning of that hearing, I was fired by my attorney's office and a pro-se substitution form was completed and submitted. This firing left me in a complete legal fog and I felt an enormous amount of pressure to deal with my three claims on the day of court. Under extreme duress, I agreed to the stipulations presented that day. In light of my re-injuring the same knee on 6/29/2011, it was a mistake for me to have agreed to these stipulations without having counsel present on 3/8/2011. As my fourth claim continues to proceed through the WC system, having two of the original claims [those within the 5-year window] reopened to track along would not pose an undue burden on any of the parties involved.
