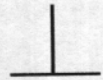


I am requesting a Status Hearing for the following two (2) matters:

1. That lawyers with settlement powers from both the Jackson Lewis and Stockwell Harris firms personally appear and together make a global settlement offer to the applicant. Lawyers from both law firms have previously appeared in this WCAB case and have been involved for a number of years with this applicant. This global settlement effort was initiated by Judge Hall several years ago and never manifested into fruition.
  - A. I ask the parties to appear and show evidence of all previous written offers made to show compliance with Judge Halls order.
  - B. I ask that Jackson Lewis produce all documents on the offers made during the handling of Dan Quinn mediations and the EEOC claims of my case.
2. That all surveillance materials be turned over to the applicant from all parties who have appeared in my WCAB hearings, whether directly or indirectly hired. If none of the surveillance evidence is going to be used against me, then I'd ask for a declaration in writing to that effect to be handed to me on the day of the WCAB hearing. 5 years surveillance is excessive and I feel violated by the refusal to comply in good faith.

Unless a status or priority conference is requested, I have completed discovery on the issues listed above, and that all medical reports in my possession or control have been filed and served as required by the rules promulgated by the Court Administrator.
