Dear Investigations Section:

I wanted to give you an update on my most recent interaction with QME evaluator Dr. Tabaddor. I attended the QME appointment with Dr. Tabaddor on Monday, May 9th, 2016. My appointment was scheduled for 3:30 pm and I arrived early at about 3:15 pm.

Dr. Tabaddor immediately scolded me for not arriving at 3 pm. Nowhere on any appointment notice was I told to arrive 30 minutes early. The motivation behind his hurry became obvious when he told me that had two (2) depositions scheduled for that same afternoon, at 4 pm and at 5 pm. So essentially Dr. Tabaddor had given me only 30 minutes for our examination; an examination that had taken many months to achieve.

Thankfully, the examination was videotaped and this tape will best show the manner and tone of our interactions. Despite having seen me many times over the last five years, Dr. Tabaddor proceeded to waste our limited time by going over the genesis of each injury and the specific harms caused by each one. These are things that we had already covered and that he should have had down pat, many years ago. We never did get to my current medical state.

Dr. Tabaddor yelled at me and then cut off our time due to his other commitments. The tape will reveal this and I urge you to watch it before making any final decision on my complaint against Dr. Tabaddor. The videographer can be reached at 1-800-288-3376, and the contact person is Vicki Briggs. I've requested a copy of the tape already but I've been told that it could be as long as a 30 day delay. I am hopeful that you won't have to experience that same delay.

I am not willing to voluntarily see Dr. Tabaddor again and would be open to having a new QME evaluate my orthopedic needs. The videotape should make Dr. Tabaddor's unprofessionalism towards me objectively apparent. Neither I nor any other injured party should have to be subjected to the lack of bedside manner (unprofessionalism) that Dr. Tabaddor has exhibited towards me.
