Dear Dr. Bronshvag:

I am writing you to follow up and keep my matters moving forwards, toward an improved resolution. I saw Dr. Carey per your referral. I have not, however, seen his report and would request a copy from you, along with your reason for this referral. I thought that it was for the chemical effects to my central nervous system. He caught me off guard when he began questioning me about the sexual harassment, retaliation, etc.

Upon arriving at Dr. Carey's office I was expected to turn in a 20-page questionnaire. I hadn't previously been told about the questionnaire so that both bothered Dr. Carey's staff and ultimately cut into the allotted time that I had with him. He was nice enough to actually have me come back again the next day.

Seeing Dr. Carey really wiped me out emotionally and I felt the need for immediate psychiatric help after leaving his office. I had a lot of suppressed feelings that came gushing forth and we weren't able to even get beyond the surface issues. After meeting with him I felt that my immune system was extremely compromised, shot. As I have no medical coverage, I ask that you remain aware that I have no support system to help me recover from these types of appointments. Please be gentle with my weakened emotional and psychiatric systems.

In terms of requested referrals, please see the letter that I sent today to Dr. Tabaddor and copied to you. In that letter I express my need for referrals to a dermatologist, an allergy specialist, and a chiropractor. Please see the enclosed materials that go towards supporting these referrals.

From you Dr. Bronshvag, I am strongly in need of a referral to a gynecologist as I am having numerous issues. Years ago at my last gynecological appointment, I had a benign tumor. I'd specifically ask for a CA 125 blood test to check for ovarian cancer. Additionally, I need a referral to an ophthalmologist as I am having issues with my diminished vision. Please see the enclosed materials that go towards supporting these additional referrals. These barely scratch the surface and in the coming weeks I will be sending you supporting evidence for referrals and my need for immediate full medical care.

To get a view of my last appointment with Dr. Tabaddor, I'd appreciate your going to my website culexpien.com and watching the court-authorized videography. The examination did not last very long. Thank you for all of your professional attention towards these matters.


