The District is not obligated to create new documents nor is it obligated to provide narrative responses to questions. In addition, the District is not obligated to post your requested information on the District's web-site.

The District will not produce records that are privileged unless such privileged information can be redacted so as to provide relevant information. The District will provide the records that are available; however, you seek information on some individuals last employed more than a decade ago. It will take additional time to find and copy those records. Once copied, the District will make the records promptly available upon payment of fees covering direct costs of duplication, or a statutory fee if applicable.

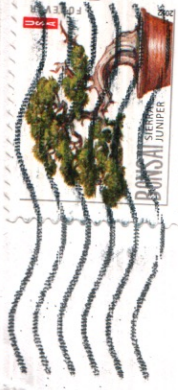
